To Whom It May Concern:

This letter is to inform you that due to business reasons, Enrollease, Inc. (the "Company" or "Ease") and its sister/affiliated entity Employee Navigator, LLC ("Navigator"), recently conducted layoffs at its Las Vegas, Nevada; San Francisco, California; Omaha, Nebraska; and Bethesda, Maryland worksites, which may trigger the state and federal Worker Adjustment and Retraining Notification Acts ("WARN"). To be clear, while we do not believe that these employment actions will trigger WARN in each of the worksites (which are separate worksites), out of an abundance of caution, we are providing you with the following information in accordance to WARN.

Accordingly, out of abundance of caution, this letter constitutes the required notice under WARN. The information is based on the best information currently available.

- 3. The layoffs are expected to be permanent, and will occur on April 30, 2023, and the total number of affected employees is 93, consisting of:
  - 49 Ease employees who work in the Ease's Las Vegas, Nevada employment site (of whom 40 are remote employees who work outside of Nevada but may report into this worksite),
  - 25 Ease employees who work in the Ease's San Francisco, California employment site (of whom 13 are remote employees who work outside of California but may report into this worksite),
  - 17 Ease employees who work in the Company's Omaha, Nebraska employment site, of whom 13 are remote employees who work outside of Nebraska but may report into this worksite,
  - 2 Navigator employees who work in Navigator's Bethesda, MD employment site.
- 4. The layoffs did not lead to an entire plant closure in any employment site.
- 5. Again, the date of the first applicable employment termination was April 30, 2023.<sup>1</sup> Additional employment terminations are not yet anticipated at this time.
- 6. Ease and Navigator were not able to give a full 60-days' notice to all affected employees, and indeed may not be required to in all instances. However, all affected employees who did not receive a full 60-days' notice are receiving base salary/wages continuation and benefits in an amount equal to the compensation and benefits they would have received during the applicable notice period. *See* Cal. - 8. Affected employees do not have any bumping rights as to other employees.

9. None of the affected employees are covered by a collective bargaining agreement. The affected employees are not represented by any union or union official.
