To Nebraska's Rapid Response Administrator,

This document constitutes notice pursuant to the Worker Adjustment and Retraining Notification Act, 29 U.S.C. Section 2101 *et seq*. ("WARN Act") that Becton, Dickinson and Company ("BD") has made the business decision to permanently move syringe and needle manufacturing operations from BD's Holdrege site located at 1329 US-6, Holdrege, NE 68949, to other existing BD facilities. BD is not closing the site as it will continue to retain other operations and services at the site.

Based on the best information available to BD as of the date of this notice, this change of operations, including the transition of manufacturing lines, is expected to result in the separation of employment for 107 employees, with the majority of such employees separating October 20, 2023, and the remaining such employee separations occurring later, the last of which is expected to occur on or about September 30, 2024.

These separations are "permanent" as defined by the WARN Act. The affected employees are not represented by a union, and they will not have bumping rights.

A list with the scheduled date of the first separations and schedule for later separations is included with this letter. The schedule identifies the job titles of positions that will be affected, and the number of affected employees in each such job classification.

All employees whose jobs will be eliminated in this event at this site will receive at least 60 days' written notice in advance of the effective date of the termination of their position. In accordance with and subject to the terms of any applicable severance plan, full-time employees will be eligible for severance pay and benefits beginning upon the termination of their employment. Outplacement assistance is being provided to affected employees. Moreover, affected employees are being provided opportunities to seek other roles within BD, including at other facilities.

We have also notified the Office of the Chairman for the Board of Commissioners of Phelps County and the Mayor for the City of Holdrege.
