REFERENCES: Workforce Innovation and Opportunity Act of 2014 (WIOA); 20 CFR 683.110

PURPOSE: To require the return of unexpended WIOA Title IB funds allocated for

Program Year (PY) 2014

SUBSTANCE: Funds allocated to local workforce development areas (local areas) for a

program year for the WIOA Title IB Adult, Dislocated Worker, and Youth programs are available for expenditure by the local workforce development board (local board) during that program year and one (1) succeeding program year. Funds not expended during this two (2) year period of performance must be returned to the Nebraska Department of Labor

(NDOL).2

As required under 20 CFR § 683.110(c)(2), the following local boards must return the unexpended amounts summarized below:

- The Greater Nebraska Workforce Development Board must return \$3.15 in PY 2014 funds and \$30.63 in FY 2015 funds.
- The Greater Omaha Workforce Development Board must return \$0.60 in PY 2014 funds.

Attachment 1 provides an itemization of the funds that must be returned.
