PURPOSE:

To provide the adjusted amounts of WIA Title I Dislocated Worker Program

allocations for Program Year (PY) 2013 to Local Workforce Development

Areas for planning purposes

REFERENCE:

Workforce Investment Act of 1998 (WIA) Sections 128, 133, and 189; 20 CFR §§ 20 667.107 and 677.160; Nebraska Department of Labor (NDOL) Allocation

Planning Policy (Rev. 5/2013) and Record Retention Policy (Rev. 03/25/14)

SUBSTANCE:

The allocation levels for WIA Title I Dislocated Worker Program PY 2013 funds

have been adjusted.

This adjustment follows the recapture and reallocation of \$8,870.93 of FY 2014 Dislocated Worker Program advance funds allocated to the Greater Omaha Workforce Development Area during PY 2013 that were not expended by June 30, 2015 and are not obligated. This recapture and reallocation is permitted under and performed in keeping with WIA Sections 128(c) and 133(c) and 20 CFR § 677.160 and NDOL's Allocation Planning Policy (Rev. 5/2013).

The recaptured funds are reallocated to the Greater Nebraska and Greater Lincoln Workforce Development Areas based on the relative amount originally allocated to these local areas for their respective Dislocated Worker Programs for PY 2013. The reallocation is applied as follows:

Each of the Greater Nebraska and Greater Lincoln Workforce Development Areas must expend the reallocated Dislocated Worker Program funds on or before June 30, 2016 as required by 20 CFR § 667.107(b).

ACTION:

Acceptance of the reallocated Dislocated Worker Program funds obligates the Greater Nebraska and Greater Lincoln Workforce Development Areas to properly report their expenditures for their respective Dislocated Worker Programs in accordance with all applicable NDOL policies, including NDOL's Record Retention Policy (Rev. 03/25/14) and each local area's applicable policies.

<u>Local Workforce Development Areas must submit a plan revision to reflect the changes resulting from this issuance no later than January 31, 2016.</u>
