PURPOSE:

To inform Local Areas of the continuation of negotiated PY 2014 State WIA

and Wagner-Peyser Act Performance Goals through PY 2015

REFERENCE:

SUBSTANCE:

On April 28, 2015, the Employment and Training Administration (ETA) issued TEGL 30-14 which indicated ETA's intent to extend states' PY 2014 the performance goals into PY 2015. TEGL 30-14 provided states with options for negotiating revised PY 2015. Each of the three (3) Nebraska local workforce development areas elected not to renegotiate performance goals for PY 2015 and to extend the PY 2014 performance goals into PY 2015.

On May 15, 2015, the Commissioner of Labor on behalf of the Governor notified the Employment and Training Administration Region V Office (ETA Region V) of Nebraska Department of Labor's intent to extend into PY 2015 the negotiated PY 2014 state WIA and Wagner-Peyser Act performance goals. As referenced in TEGL 30-14, ETA allowed states to extend all currently negotiated PY 2014 goals going forward into PY 2015 to provide for an orderly transition from WIA to WIOA.

On June 15, 2015, ETA Region V notified the Commissioner of Labor of its agreement to extend the PY 2014 performance goals through PY 2015 (see Attachment A). ETA Region V's notification also constitutes a modification to the State of Nebraska Five-Year Integrated Workforce Plan (State Plan). The state must ensure that the PY 2015 performance goals are included in the state's official copy of its State Plan. Any published copy of the State Plan on the state's website must also include these PY 2015 goals. ETA will incorporate

these performance goals into the Regional and National Office copies of the State Plan.
