Healthcare Support Occupations

Nebraska workers employed in healthcare support occupations statewide in 2019. (1)

Number of healthcare support occupations projected to see a decrease in total employment in Nebraska from 2018 to 2028. Pharmacy aides are the only occupation expected to shrink during this decade, with a projected decline of 5.9%. (2)

Spotlight: Nebraska Senior Care Occupations

Occupations involved in caring for senior citizens in Nebraska and nationwide include registered nurses, licensed practical nurses (LPNs) and licensed vocational nurses, medical assistants, nursing assistants and orderlies, social and human service assistants, and many more.

One of the most common occupations within the senior care industry is home health aides and personal care aides, who may work in assisted living facilities or "in a variety of settings, including clients' homes, group homes, and day services programs." (1)

According to the Bureau of Labor Statistics (BLS), typical duties for personal care aides include:

- assisting clients in their daily personal tasks, such as bathing or dressing;
- housekeeping, such as laundry, washing dishes, and vacuuming;
- helping to organize a client's schedule and plan appointments;
- arranging transportation to doctors' offices or other outings;
- shopping for groceries and preparing meals to meet a client's dietary specifications;
- keeping clients engaged in their social networks and communities;
- checking in with clients to ensure that services are provided appropriately;
- helping to determine what type of aid their clients need;
- assessing patients' conditions;
- recording patients' medical histories and symptoms;
- observing patients and recording the observations;
- operating and monitoring medical equipment. (1)





Nebraska Wages for Home Health and Personal Care Aides, Q3 2020

The median annual wage for home health and personal care aides in Nebraska was \$26,731 as of the third quarter of 2020. This was slightly less than the median wage for all occupations, which was \$39,512. (2)

The top industry of employment for Nebraska's home health aides as of 2018 data was social assistance (60.1%). Ambulatory health care services (17.1%) and nursing and residential care facilities (14.3%) were also major employers of workers in this occupation. (3)

Nurses, including registered nurses and licensed practical and licensed vocational nurses, are also important workers within the senior care industry.

Duties for licensed practical and licensed vocational nurses typically include:


- monitoring patients' health—for example, by checking their blood pressure;
- administering basic patient care, including changing bandages and inserting catheters;
- providing for the basic comfort of patients, such as helping them bathe or dress;
- discussing the care they are providing with patients and listening to their concerns;
- reporting patients' status and concerns to registered nurses and doctors;
- keeping records on patients' health. (1)

For registered nurses, major job duties include:

- assessing patients' conditions;
- recording patients' medical histories and symptoms;
- observing patients and recording the observations;
- administering patients' medicines and treatments;
- setting up plans for patients' care or contributing information to existing plans;
- consulting and collaborating with doctors and other healthcare professionals;
- operating and monitoring medical equipment;
- helping perform diagnostic tests and analyzing the results;
- teaching patients and their families how to manage illnesses or injuries;
- explaining what to do at home after treatment. (1)

In the third quarter of 2020, Nebraska's licensed practical and licensed vocational nurses earned a median annual wage of \$45,501, while registered nurses earned \$66,354. Both occupations brought home a higher median paycheck than the all-occupations median of \$39,512 during that quarter. (2)


Nebraska Wages for Nurses, Q3 2020

According to 2018 data, licensed practical and licensed vocational nurses in Nebraska most often tended to by employed within nursing and residential care facilities (32.7%), followed be ambulatory health care services (32.5%). Hospitals (19.7%) were also major employers of these workers. (3)


Nebraska Industry of Employment Licensed Practical and Licensed Vocational Nurses, 2018

Registered nurses in Nebraska were most likely to be employed in hospitals (58.7%), ambulatory health care services (17.6%), or nursing and residential care facilities (9.4%) as of 2018. (3)

Social and human services assistants also play an important role in the senior care industry. According to the BLS, "these workers help clients stay in their own homes and live under their own care whenever possible. Social and human service assistants may coordinate meal deliveries or find personal care aides to help with the clients' day-to-day needs, such as running errands and bathing. In some cases, human service assistants help look for residential care facilities, such as nursing homes." (1)

Typical job duties for social and human services assistants include:

- helping determine what type of aid their clients need;
- working with clients and other professionals, such as social workers, to develop a treatment plan;
- helping clients find assistance with daily activities, such as eating and bathing;
- researching services, such as food stamps and medicaid, that are available to clients;
- coordinating services provided to clients;
- helping clients complete paperwork to apply for assistance programs;
- checking in with clients to ensure that services are provided appropriately. (1)

The median annual wage for social and human service assistants working in Nebraska was \$ 32,795 in third-quarter 2020. This was slightly lower than the state's all-occupations median for the quarter. (2)


Nebraska Wages for Social and Human Service Assistants, Q3 2020

The top industry of employment for Nebraska's social and human service assistants as of 2018 was social assistance (39.2%). Nursing and residential care facilities (28.8%) was also a major employer for this occupation. (3)









The labor force is comprised of all persons age 16 and over in the civilian, noninstitutional population who are either employed or unemployed but available for work and actively seeking employment. It excludes people doing unpaid homemaking or volunteer work, retired people, and people who are not employed and not actively seeking work. The labor force participation rate measures the labor force as a percentage of the total civilian, noninstitutional population, age 16 and over.1





FHFA Purchase-Only Housing Price Index

The housing price index (HPI) measures the movement of single-family house prices, based on purchases involving conventional mortgages purchased or securitized by Fannie Mae or Freddie Mac. "Four-quarter" change is relative to the same quarter one year earlier. HPI data are often considered useful for estimating housing affordability and projecting future changes in mortgage default rates.⁵


