# INFRASTRUCTURE FUNDING AGREEMENT Between THE GREATER NEBRASKA WORKFORCE DEVELOPMENT BOARD, THE GREATER NEBRASKA CHIEF ELECTED OFFICIALS BOARD, and NEBRASKS DEPARTMENT OF LABOR Unemployment Insurance

THIS INFRASTRUCTURE FUNDING AGREEMENT is entered into between the Greater Nebraska Workforce Development Board (GNWDB), the Greater Nebraska Chief Elected Officials Board (GNCEOB), and the Nebraska Department of Labor, Office of Unemployment Insurance (PARTNER), and is incorporated into and made a part of the Memorandum of Understanding between GNWDB, GNCEOB, and PARTNER, entered into in June of 2017, in accordance with the Workforce Innovation and Opportunity Act (WIOA).

### I - PARTNER Cost Allocation for Infrastructure Costs

- A. The cost allocation formula is based on customers served as reported by PARTNER in each district of the American Job Centers (AJCs) in Beatrice and Grand Island, Nebraska. The funds support the resource rooms in the AJCs, and comprise the costs of lease, facility maintenance, property and casualty insurance, cleaning services, utilities, and equipment. Calculation of infrastructure costs is set forth in Attachment-f-1 of this Attachment.
- B. Actual costs for the items set out in section (I) (A) will be reviewed by GNWDB and GNCEOB at the start of each program year, and contributions will be adjusted annually.
- C. The financial commitment of PARTNER is set out and incorporated into the Infrastructure Funding Agreement between the Greater Nebraska Workforce Development Board and the Greater Nebraska Chief Elected Officials Board, with the following programs of the Nebraska Department of Labor:
  - · Adult, Dislocated Worker, and Youth (WIOA Title I);
  - Wagner-Peyser Employment Services (WIOA Title III);
  - Jobs for Veterans' State Grants (VSG) (38 USC Chapter 41);
  - Trade Adjustment Assistance (TAA) (Neb. Rev. Stat. §48-617); and
  - Unemployment Insurance.

That Infrastructure Agreement is attached as Attachment-F and Attachment-F-1 and incorporated into the Memorandum of Agreement executed in June of 2017 that includes the parties indicated above, except for the Office of Unemployment Insurance, which has a separate MOU.

- D. This Infrastructure Agreement shall be attached as Attachment-F to the Memorandum of Agreement executed in June of 2017 between the Greater Nebraska Workforce Development Board, the Greater Nebraska Chief Elected Officials Board, and the Nebraska Department of Labor, Unemployment Insurance.
- E. The schedule for the PARTNER's payments shall be coordinated with the Administrative Entity. Nebraska Department of Labor, Office of Finance.
