# **SUBJECT**

Return of unexpended WIOA Title I program funds allocated for Program Year 2022

### PURPOSE

To provide CEOs and Local Boards with information about mandatory return of unexpended WIOA Title I program funds allocated for Program Year 2022 (PY22), as required under 20 CFR \$ 683.110(c)(2) in accordance with WIOA Secs. 128(c) and 132(c)

### ACTION

As required under 20 CFR 683.110(c)(2), the Greater Nebraska Workforce Development Area must return unexpended PY22 funds in the amount of \$37,246.03. Attachment I provides an itemization of the funds that must be returned.

## NOTICE

Funds allocated to local workforce development areas for WIOA Title I adult, dislocated worker, and youth programs for a given program year are available for expenditure during initial program year and one succeeding program year, collectively known as the period of performance.<sup>1</sup> Funds not expended during a period of performance must be returned to NDOL.<sup>2</sup>
