Dissemination of Governor's reserve funds to support the provision of career services by local area Title I adult programs within Nebraska's statewide one-stop delivery system

PURPOSE

To provide Chief Elected Officials, local boards, and local area administrative entities with information regarding dissemination of \$166,626.54 from the Governor's reserve to support the provision of career services by local area Title I adult programs within Nebraska's one-stop delivery system

ACTION

Funds disseminated to local areas, as described below, must be used for the provision of career services by local area Title I adult programs. Local areas must fully expend the funds by June 30, 2021. Any funds not expended by June 30, 2021 must be promptly returned to NDOL.

NOTICE

NDOL is disseminating \$166,626.54 from the Governor's reserve to support the provision of career services¹ by local area Title I adult programs within Nebraska's one-stop delivery system, as permitted pursuant to 20 CFR § 680.610(h).

Amounts to be disseminated to each local area are detailed in Table 1 and are based on the allocation methodology used by NDOL when calculating annual local area Title I adult program funding allocations.
