## Dear Rapid Response Administrator:

This Notice is being provided by Omaha Steaks International, Inc. (hereinafter "Omaha Steaks" or "Company"), in conjunction with the Worker Adjustment and Retraining Notification Act of 1988 ("WARN Act"), which requires employers to give notice of a pending facility closure. Omaha Steaks has made the difficult decision to permanently discontinue all operations at its Snyder facility located at 501 E 4th St, Snyder, Nebraska, effective March 15, 2023.

Up to 65 employees will suffer a permanent employment loss as a result of this facility closing on March 15, 2023. However, all 65 employees will be offered continued employment with Omaha Steaks at their current job title and existing rate of pay at our operation located at 4400 South 96<sup>th</sup> Street in Omaha, Nebraska (the "96<sup>th</sup> Street location"). If more than 15 employees accept the opportunity to transfer to the 96<sup>th</sup> street location, Omaha Steaks will not incur any obligations under the WARN Act. However, Omaha Steaks is providing this notice out of an abundance of caution, as it is difficult to predict how many employees will accept this transfer opportunity.

All impacted employees will be provided with no less than 60 days full pay from the date of this letter, in addition to any supplemental benefits or assistance for which they may be eligible, including health insurance coverage paid by Omaha Steaks through May 31, 2023. Omaha Steaks is also partnering with local community leaders to provide assistance to any impacted employees as they explore new employment opportunities.

Affected employees do not have any "bumping" rights against unaffected employees. The affected employees are not represented by a union.
