SUBJECT

Return of unexpended WIOA Title I program funds allocated for Program Year 2019

PURPOSE

To provide CEOs and Local Boards with information about the mandatory return of unexpended WIOA Title I program funds allocated for Program Year 2019, as required under 20 CFR § 683.110(c)(2) in accordance with WIOA Secs. 128(c) and 132(c)

ACTION

As required under 20 CFR § 683.110(c)(2), the following local workforce development areas must return the unexpended amounts summarized below:

- Greater Lincoln Workforce Development Area: \$72,990.36
- Greater Nebraska Workforce Development Area: \$291,614.79

NOTICE

Funds allocated to a local workforce development area for WIOA Title I adult, dislocated worker, and youth programs for a program year are available for expenditure during that Program Year and one succeeding Program Year, known as the period of performance.¹ Funds not expended during the period of performance must be returned to NDOL.²
